

## TGI FRIDAY'S WBC FAN FAVORITE VOTING TERMS AND CONDITIONS

ONE VOTE PER PERSON, PER DAY. ALL VOTES MUST BE MANUALLY KEY - STROKED AND USE OF ANY AUTOMATED PROGRAM/SYSTEM/APPARATUS/MECHANISM TO VOTE IS PROHIBITED AND WILL RESULT IN THOSE VOTES NOT BEING COUNTED. TGI FRIDAY'S INC. AND ITS AGENCIES WILL HAVE NO LIABILITY AND WILL BE HELD HARMLESS FOR ANY ERRORS, MALFUNCTIONS OR FAILURES THAT OCCUR DURING THE VOTING OR TABULATION PROCESS REGARDLESS OF CAUSE. **SHOULD TGI FRIDAY'S INC.
